





Sir,

As per the provision of section 65 (4) of Maharashtra University of Health Sciences Act 1998, I am directed to communicate the decision of Academic Council of this University, taken in its meeting held on 29/07/2008. The Academic Council resolved to grant First Affiliation vide its resolution No. 338/2008 to your college viz. **Late Pandurang Patil Nursing (B.Sc.) College, At/po. Kanheri (Sarap), Tal. Barshitakli, Dist. Akola for the academic year 2008- 09** subject to the following conditions:

- 1) The intake capacity shall be 40 students.
- 2) Fulfillment of norms and conditions laid down by Indian Nursing Council.
- 3) Rules and Regulations made by the Govt. and the University, as amended from time to time, will be binding on the College.
- 4) The following deficiencies pointed out by the LIC should be fulfilled within a period of 01 month :-
 - a) Permission letter of District Health Officer, Akola regarding use of General Hospital, Akola along with details of bed strength.
 - b) Details of bed strength of P.H.C Kanheri Sarap, Dist. Akola.
 - c) Number of Library books should be increased as per INC norms, i.e. 750 books for 1st year B.Sc. Nursing.

College should send compliance report on fulfillment of above deficiencies to the University within a month. On receipt of compliance report, the University will appoint a committee to verify the teaching staff & infrastructure of the college.


